MEMBERSHIP AGREEMENT

IN CONSIDERATION of the Unionville Cycling Club's acceptance of my application for membership in the **UNIONVILLE CYCLING CLUB** (the "Club"), **I HEREBY:**

- (1) WAIVE ANY CLAIMS, DEMANDS, ACTIONS OR CAUSES OF ACTION AGAINST THE CLUB AND ITS DIRECTORS, OFFICERS, EXECUTIVE MEMBERS, AGENTS AND ANY OTHER PERSON OR ORGANIZATION FOR WHOM IT IS RESPONSIBLE IN LAW;**
- (2) RELEASE THE CLUB** from any claims, demands, actions or causes of action to which I may become entitled in law or equity, arising out of, or resulting from, any loss, injury or damage to my person, or to any other person in law for whom I am responsible, or to my property, while I am participating in a Club ride or event, or while I am on any premises rented, licensed or used by the Club, notwithstanding that any such loss, injury or damage may have been caused by the intentional or negligent acts of, or breach of contract by, the Club, including any of its directors, officers, agents, members and any other person or organization for whom it is responsible in law;
- (3) AGREE TO INDEMNIFY THE CLUB** from any claims or demands in law or equity, which might be made against the Club by any person arising out of, or resulting from, any intentional or negligent conduct or breach of contract on my part while I am participating in a Club ride or event, or while I am on any premises rented, licensed or used by the Club;
- (4) ACKNOWLEDGE AND AGREE THAT** although my membership fee may include "sport accident insurance coverage", such insurance is **NOT INTENDED TO BE PRIMARY INSURANCE** and that notwithstanding the purchase of such insurance by the Club, **I AGREE TO ASSUME SOLE RESPONSIBILITY FOR ARRANGING MY OWN PRIMARY INSURANCE** against any loss, injury or death sustained by me or my estate while I am participating in a Club ride or event, or while I am on any premises rented, licensed or used by the Club;
- (5) DECLARE THAT I AM IN PROPER PHYSICAL CONDITION TO PARTICIPATE IN ROAD CYCLING;**
- (6) ACKNOWLEDGE THAT ROAD CYCLING IS A DANGEROUS PHYSICAL ACTIVITY AND I AGREE TO FULLY ASSUME ALL RISKS ASSOCIATED WITH MY PARTICIPATION IN THIS ACTIVITY,** including by way of example, and not limitation, the following risks: collision with pedestrians, vehicles, other riders, fixed or moving objects, animals; the dangers arising from surface hazards, equipment failure, inadequate safety equipment, and weather conditions; and the possibility of **SERIOUS PHYSICAL AND/OR MENTAL TRAUMA OR INJURY ASSOCIATED WITH CYCLING, INCLUDING DEATH;**
- (7) ACKNOWLEDGE AND AGREE THAT THE CLUB IS UNDER NO OBLIGATION TO PROVIDE ME WITH INSTRUCTION OR TRAINING ON BICYCLE RIDING SKILLS OR BICYCLE MAINTENANCE AND I CONFIRM THAT I HAVE THE RIDING SKILLS AND KNOWLEDGE REQUIRED TO RIDE A ROAD BIKE, INCLUDING AS PART OF A GROUP RIDE, AND AM ABLE TO MAINTAIN MY OWN BICYCLE IN PROPER AND SAFE RIDING CONDITION;**
- (8) AGREE TO ABIDE BY THE CLUB CONSTITUTION, BY LAWS AND RULES, AS AMENDED FROM TIME TO TIME and ACKNOWLEDGE** that this Application and Agreement will govern my membership in the Club for as long as I pay the annual Membership fee as required;
- (9) CONFIRM** that I am familiar with, and agree to abide by all, **HIGHWAY TRAFFIC LAWS; AND AGREE TO PRACTICE COURTESY AND SAFETY IN CYCLING.** I understand helmets are required to avoid serious head injury and I AGREE to wear a suitable helmet when riding my bicycle.

I HAVE READ AND UNDERSTOOD THIS APPLICATION AND THE TERMS GOVERNING MEMBERSHIP SET FORTH ABOVE. I AGREE TO BE BOUND ALL OF THE TERMS SET FORTH ABOVE AND ALSO AGREE THAT THIS AGREEMENT WILL REMAIN IN EFFECT FOR AS LONG AS I CONTINUE TO BE A MEMBER OF THE CLUB AND THAT THIS AGREEMENT IS BINDING ON MY HEIRS, PERSONAL REPRESENTATIVES, TRUSTEES, SUCCESSORS AND ASSIGNS.
